

External Financing and Scholarship Opportunities

Government and Federal Aid Option

1. **Germany: BAföG**

Eligibility: All international students

BAföG for foreign students

Award: Students who still live with their parents receive basic assistance in the amount of **422€**. Students with their own flat receive **597€**, independent of the actual amount of rent paid. If the student's flat costs more than 146€ per month, then the BAföG office pays an additional 64€. In addition, BAföG provides **73€** for health insurance and long-term care insurance. In total, students who live with their parents can receive a maximum of **495€** and the others **670€**.

You can apply for BAföG if you fulfill the criteria of §8 BaföG law (<https://www.xn--bafg-7qa.de/de/-8-staatsangehoerigkeit-224.php>). That means that foreign students can receive BAföG should they have already lived in Germany for some years or plan to stay in Germany for a long period of time. Students with recognized refugee status in Germany are also eligible for BAföG. For EU-citizens it is usually much easier to apply for BAföG than for non-EU citizens. Furthermore you have to be younger than 30 years of age at the beginning of your studies. Your application will be verified according to your and your parent's earnings. If your own property is valued at more than 5.200 Euro or your parents earn more than the criteria in §24 BAföG law allows, you are not eligible to receive BAföG. You can find various BAföG calculation tools in the web and get further information at the BAföG office at your student union. Keep in mind that you will have to repay 50% of the disbursements you have received on an interest-free base. You have to start repayment for the loan-part 5 years at latest after finishing your study.

2. **Austria: Studien Beihilfen**

Eligibility: Austrian citizens, EU citizens, and registered refugees have the opportunity to apply for financial aid from the Austrian government. Please see the first link for more information about who qualifies.

Award: The amount of student aid granted is determined with reference to household income and personal need. Austrian students who are studying outside of Austria do have the chance to receive financial aid for their studies. Please see the second link about Austrian financial aid abroad.

3. Belgium: Bourses d'Études

Eligibility: Financial aid is available for Belgian students. Eligibility depends on which language speaking community one belongs to. Because of this, it is important to see whether the financial aid can be applied to universities outside of Belgium. See the link below to find out eligibility and award potentials.

4. France: Bourse sur Critieres Sociaux

Eligibility: French citizens, EU citizens, and registered refugees have the opportunity to apply for financial aid from the French government based on university enrollment as well as your socioeconomic status. Students applying need to submit tax forms and a confirmation of enrollment from their university. Please see the first link for specific requirements and regulations governing eligibility.

Award: The amount of student aid granted is determined in accordance with household income and personal need. French students studying within an EU country at university of a French equivalency have the opportunity to receive financial aid. There is also an opportunity to receive a travel stipend should the student qualify.

5. Netherlands: Dienst Uitvoering Onderwijs

Eligibility: If you are the citizen of a EU/EEA-country or Switzerland, you will qualify for student finance if you have been living in the Netherlands for 5 consecutive years or more, or, if you or your non-Dutch parent or partner work in the Netherlands for at least 56 hours a month.

If you are not a national of an EU/EEA-country or Switzerland, you can still qualify for student finance if you have a residence permit type II, III or IV.

Award: Student finance comprises 3 components: a loan, a student travel product and a supplementary grant (depending on parental income). To find out what the income limit is and how much supplementary grant you can get., use calculator on the website

6. Portugal: Borse

Eligibility: The Portuguese government offers financial aid to Portuguese students. Please see their terms and conditions to verify whether government financial aid is applicable to other EU institutions.

7. United States: Free Application For Student Aid (FAFSA)

FAFSA Eligibility:

Students who:

- are U.S. citizens, U.S. nationals or eligible non-citizens
- have a valid Social Security Number
- have a high school diploma or GED
- are registered with the U.S. Selective Service (if you are a male aged 18-25)
- complete a FAFSA promising to use any federal aid for educational purposes

- do not owe refunds on any federal student grants
- are not in default on any student loans, and
- have not been found guilty of the sale or possession of illegal drugs during a period in which federal aid was being received.

FAFSA deadlines are set by federal and state agencies, as well as individual school financial aid offices, and vary widely. Some schools have deadlines as early as the second week in January!

Scandinavian Countries

1) Sweden

Eligibility: If you are registered as a Swedish citizen, hold a Swedish passport, or are a permanent resident of at least 5 years, you are eligible for CSN.

Award: Student finance comprises different components. You can either register for a loan, for support for your studies, or be eligible for both. The sum you receive is usually standardized but also depends on your age, income, and family situation (married, with children, etc.)

2) Norway

Eligibility: Much like the Swedish CSN, the Norwegian Lånekassen applies to Norwegian citizen or passport holders, but some internationals can be eligible under certain circumstances.

Award: Lånekassen is based on loans, and so the sum can differ depending on what is requested and the circumstance of study.

8. Evangelisches Studienwerk Villigst

Eligibility: Eligible students come from the European Union or a candidate country of the European Union and are enrolled at a German institute of higher education, have a good academic record, a proven interest in social engagement, and are members of an evangelical church (with certain exceptions). Students must not be beyond their third semester of study and must provide evidence of good knowledge of German (the Deutsche Sprachprüfung für den Hochschulzugang).

Award: funding covers up to 649 Euros per month plus 300 Euros study cost allowance

9. Hans Böckler Stiftung

Eligibility: Students who want to study at a university in a Member State of the European Union or in Switzerland.

Deadline (Fall Semester): April 30th

10. Konrad Adenauer Stiftung

Eligibility: Prospective or current German undergraduate students who have an excellent academic record and an interest in social and political engagement and the furtherance of Christian-democratic values.

Award: stipends of up to 597EUR (depending on the economic situation of the parents) are available plus a study cost allowance 300EUR. Study abroad can be up to two semesters financially supported. All benefits are granted as non-repayable grants.

11. Rosa Luxemburg Stiftung

Eligibility: German undergraduate students with an excellent academic record and a proven record of social engagement in accordance with the aims of the Rosa Luxemburg Foundation. Students can apply after the second semester of B.A. study; they must have at least half of their B.A. program still to complete.

Eligibility: German and EU students enrolled at a German institute of higher education who have an excellent academic record; students can apply independently or be proposed by the institution at which they are enrolled after one year of study.

Eligibility: Citizens of the UK are eligible to apply for awards for study or research in Germany, and German citizens for awards for study or research in the UK.

Deadline: Applications must be received by the BCCG Foundation between 1 May and 30 June.
